Terms and Conditions of Booking

- For bookings cancelled between 14 and 7 days of Hire, 50% of the Hire Fee is forfeited and deducted from the \$2000.00 (+GST) deposit.
- For bookings cancelled between 7 and 2 days of Hire, 100% of the Hire Fee is forfeited and deducted from the \$2000.00 (+GST) deposit. If the Hire Fee is greater than the deposit only the full deposit amount, \$2000.00 (+GST), will be forfeited.
- For bookings cancelled within 48 hours of Hire, the full deposit of \$2000.00 (+GST) is forfeited.
- Please ensure you have read the Hire Agreement (Parts A & B) setting out the terms and conditions for the Hire of the vehicle. The Hire Agreement is available to download on the website. The onus is on the Hirer and any Additional Drivers to ensure they are fully aware of the terms and conditions of the Hire Agreement.
